The Board discussed the City Public Works maintaining the vegetation & ditches along Depot Drive of the GDA Property. Alderman Novotney made a motion to agree that the City of Gerald Public Works will maintain the vegetation & ditches along Depot Drive at the GDA Property. Alderman Via seconded the motion. All aldermen voted "aye". Alderman Parker abstained.

The Board discussed a typo in the contract and stated it needs to be corrected. Alderman Novotney made a motion to approve the contract with the typo correction. Alderman Guerrant seconded the motion. All aldermen voted "aye". Alderman Parker abstained.

#### SCHEDULED VISITOR

*Otis Schulte with Gerald Development Association* - Presented the Rock Island Visitors Center. The GDA is working on collecting funding. They believe it will be about \$250,000. They are hoping for a fall 2025 opening date. Stated he does have a list of contractors that are willing to donate time or materials. Asked for the building permit fees to be waived and asked for water and sewer utilities supplied by the city at no cost to the GDA. Also proposed to build a replica of the original band stand gazebo near the corner of Main Street and Highway 50.

Aldermen and Building Inspector agreed to waive the fees for the building permit. Aldermen and City Administrator agreed to waive water and sewer bills. Aldermen requested City Clerk and City Administrator to investigate the cost or possibility of ensuring the building since it is not on City property.

Kathy Foy discussed information about Highway 50 and the Rock Island Trail. Gave some history of the two and more information can be found at rockislandvisitorcenter.com
