ORDINANCES & RESOLUTIONS

Bill No. 2025-04 Ordinance No. 955 An Ordinance Authorizing the Dedication of a New Roadway within the City Limits of the City of Gerald, Missouri, within the Gerald City Park.

Two readings were completed.

Alderman Novotney motioned to accept Bill No. 2025-04, Ordinance 955. Alderman Via seconded the motion. Roll call vote was done in the order of Alderman Guerrant "aye", Alderman Novotney "aye", Alderman Parker "aye", and Alderman Via "aye". Motion carried.

Resolution No. 2025-02 – Resolution No. 2025-02 A Resolution Authorizing the Filing of an Application with the Franklin County Transportation Grant Funding, authorizing a Designated Representative for Executing Required Documents on Behalf of the City, Affirming the City's Local Match, Committing to Complete the Project by the End of 2025 Award and the Finances to Operate and Maintain the Completed Project.

Mayor Koepke read the Resolution aloud to the board.

Alderman Guerrant motioned for the Mayor to sign Resolution No. 2025-02. Alderman Novotney seconded the motion. All aldermen voted "aye". Alderman Via absent. Motion carried.

Ward I Alderman Guerrant – Stated he is waiting on Reinhold to get the poles set. Stated that he and City Administrator Grube drove around town to observe storm water drains, and there are a lot of issues with that.




ADJOURNMENT
